Nothing contained herein shall be construed to void the ServerLIFT Limited Warranty for product that has arrived without damage at the final destination. Thank you for your cooperation.

I understand that it will be my responsibility to arrange, schedule and confirm the pickup of said equipment by my designated carrier at the named facility of ServerLIFT Corporation or at my named place of delivery, and that once the equipment is made available to my designated carrier, ServerLIFT Corporation and/or and of its affiliates holds no liability or responsibility for what happens to the equipment. Any problems of damage, electromagnetic interference, theft, acts of God, or any other problem, will be my responsibility, to handle and settle with our carrier(s) directly, and will not involve ServerLIFT Corporation in any way. If the equipment is damaged and not in good working order, I understand that this will be attributed to mishandling during shipping while the goods were in our possession, even if there are no visible signs of damage on the packaging.

I am an authorized agent of Buyer, and agree to the terms of shipment above by accepting all risks in handling the goods during all or part of their transport and releasing ServerLIFT Corporation of liability for any damage to the equipment that may result.
